NEW BUSINESS

a. Field Rep Vacancy Update

Sub-committee met Monday November 4, 2019 for an initial review of 11 applications to be narrowed down to 3 for interviews. Only 2 of the individuals were contacted for interviews, as the third choice withdrew their application. Discussion held on obtaining approval for \$600 to be used to promote Field Rep Position should the interviews fail to result in a hiring.

c. Classification Project

Discussed a proposed timeline agreement to be presented to the University at the next meeting, the reconsideration process, longevity, mapping, job audits, job specifications and the timeline for longevity. A discussion on job templates and their effects on the membership also took place. R. Marcellino suggested coming up with a contingency plan for dealing with frustrated members with regard to their positioning in the reclassification system. Dec. 1, 2019 is the deadline for the reconsideration timeline to be in place.

Reported on Health Cost Containment meeting and discussed Retirement Memo: annuitant letter to recalculate life expectancy of humans which defines benefits if you pass away and pass on to your annuitant. Discussion held on Article 47, phased retirement and the impact of retirement on departments.

J. Morenus

Reported that the New Member Luncheon will take place on November 12, 2019. Discussed new UCPEA Member Luncheon to take place in Stamford tentatively on November 22, 2019 and shared ideas

regarding a rotating schedule for these campuses. The cost of Storrs and regional campus UCPEA holiday parties were discussed. UCPEA has been giving \$20 /person for the UCPEA regional holiday parties – J. Morenus wishes to continue this practice. Reported on merchandise research and provided quotes. A discussion on merchandise expense approvals was held. J. Morenus to bring a sample merchandise pen to the next Executive Board meeting.

*M. White made a motion that for the Storrs UCPEA holiday party, members will pay half of the cost (including but not limited to food & beverage), except for the room fee (of \$800) and the decoration, which would be absorbed by the UCPEA, and it was seconded by J. Morenus.

*M. White made a motion to cover the actual cost up to \$20/ person for UCPEA Regional Campus Parties, and it was seconded by R. Marcellino.

*R. Marcellino made a motion to buy 500 magnets @ \$600 and it was seconded by M. White.
