Stewards will continue to voice their own concerns and the concerns of the members in their areas. Simultaneously, UCPEA is prepared to advocate for members through a Labor Board charge and a grievance.

She discussed how the committee uses the \$100,000 contractual pool of childcare funds. The committee provides a percentage of childcare reimbursement to members who apply using the forms found on the UCPEA website: http://ucpea.ct.aft.org/childcare-reimbursement. Applicants must use a state licensed
